Executive Summary

Background

Barwon Water is embarking on a project to transform our former Bellarine Basin site into more than 30 hectares of environmental and public open space to be enjoyed by the community for years to come.

With co-funding from the Department of Environment, Land, Water and Planning, we are planning to rehabilitate the Bellarine Basin and restore the natural headwaters of Yarram Creek.

We want to transform the site into an area that enhances the unique and natural features of the Bellarine Peninsula so that it becomes a place people, birds and native animals can enjoy for generations to come.

As part of our commitment to genuine and ongoing engagement, we are undertaking a three-step engagement process for input on the site design and future use. This will broadly consist of:

- Development of a vision statement, project principles and objectives
- Consideration of activities that will be accommodated on the site
- Development of a concept plan before we finalise a (landscape) masterplan and project plan for the site

Following this program there will be opportunities for the community to join us in delivering some of the initiatives, to develop and maintain the site in accordance with the vision, principles and objectives for the site.

Feedback summary


99 community members provided feedback throughout August and September 2021 on a draft vision statement, project principles and objectives that were developed by an agency advisory group (consisting of staff from Wadawurrung, Corangamite Catchment Management Authority, Department of Environment, Land, Water and Planning, City of Greater Geelong and Barwon Water).

The first phase of engagement opportunities were promoted broadly to ensure inclusive engagement, and there will be further consultation opportunities over the next 12 months. The feedback outlined in this report provides a snapshot of the community sentiment at the time.

In general, the responses were very supportive of the draft vision statement, project principles and objectives prepared by the agency reference group. Further detail is provided below.

Draft vision statement

Yarram Creek (project working title) will be a unique, inclusive and accessible community place for people to celebrate, respect, enjoy and immerse themselves in its cultural, natural and recreational values.



Level of community satisfaction with the draft vision

The majority of responses (79.6%) indicated they were either satisfied or highly satisfied with the draft vision statement.

Feedback received along with the satisfaction rating indicated strong support for a new natural area or parkland on the Bellarine Peninsula, with some noting that health restrictions had highlighted the need for more local (<5km away) places like this. There was excitement around the restoration and seeing action on site, with strong support for the site being accessible to the community.

Some respondents felt the vision needed to emphasise the protection of the natural environment, local biodiversity or linking to other areas of high biodiversity. There were some respondents who questioned the term recreational values and whether the vision statement was too people centric. Natural and passive recreation – "a quiet place in nature for reflection" – was a strong theme.

A number of respondents felt that the statement called for more detail, while others felt it covered all bases. A few respondents wanted more detail and to see the activities that would be on the site, with some advocating for a sharing of the space, others advocating specific uses (bikes, fishing, a café) and others advocating for no active recreation.

Some comments noted that the Wadawurrung name should be emphasised rather than the less specific "cultural values".

Overall the majority of those with suggested improvements were satisfied with the vision.

Draft principles


Feedback on the level of support was sought on the following draft principles:

- Accessible, safe and inclusive community place
- Connecting people to nature
- Protecting and restoring biodiversity
- Wadawurrung storytelling and spiritual connection
- Caring for and connecting to country
- Balanced, diverse and compatible experiences
- Connecting to the broader Bellarine
- Engaging community along the journey
- Sustainable design and management

As is shown in the graph above there was strong support (strongly support and somewhat support) for all draft principles. Eight of the nine draft principles had a support rating of between 80 to 90 percent.

The principle that suggested the site include balanced, diverse and compatible experiences was the only principle that had less support (73 percent).

Some respondents felt that environmental and biodiversity outcomes should be prioritised over recreational uses – or consideration given to some restricted access so that indigenous flora and fauna can flourish. There was also a number of respondents who sought clarification on what 'compatible spaces' means.

Supportive comments included:

This sounds great, love the concept, they are all good

Strong support for protecting and enhancing the natural environment and ecosystems – references to 'green' and 'wildlife' corridors Need more gardens and parks

Strong support for connection to Wadawurrung people and their culture – "respecting and acknowledging Traditional owners of the land is imperative if we want to educate the next generation."

Strong support for community involvement at the planning and implementation phases Pleased to see the site is being protected from residential development

Considerations for Barwon Water to explore:

Whether all principles could be achieved and whether having a balance of uses, or the broader community involved would compromise the conservation values Avoid crowding or over use some respondents were specifically concerned by overuse by dog walkers and bicycle riders and runners


Need more clarity on the actual site uses and activities not allowed

Draft objectives

Feedback on the level of support was sought on the following draft objectives:

Objective 1:	Nature - Protect and enhance the unique features, habitats, ecosystems and biodiversity
Objective 2:	Culture - Recognise the layers of human use and contact with the landscape, and the intangible connection of the Wadawurrung people
Objective 3:	Community - The community is involved in guiding the future of the place and ultimately connects in a range of safe and compatible recreational and nature-based experiences
Objective 4:	Sustainability - Well planned, ecologically balanced community place that can be maintained into the future

Level of community support for the draft objectives



There was strong support for all the draft objectives, with each of them receiving between 80 and 90 percent support or strongly support.

There was strong support for protecting and enhancing the natural environment, but with differing views on how this could be achieved. Community feedback identified the need for greater clarity about what it means to protect and enhance the natural environment. For some this included opportunities to enjoy through passive recreation and nature based activities. For others, it was felt human activity should be restricted to allow cultural and biodiversity values to be prioritised.

A snapshot of comments


We have also noted suggestions for minor wording changes to the draft vision, principles and objectives - including how to make certain statements clearer and more meaningful to the community.


